**CALL FOR APPLICATION**

**ARTICLE 1**

Within the activities of the Jean Monnet Module “CoRiMaR” (*Consumer's Rights and Market Regulation in the European Union*), the Department of Legal Sciences of the University of Udine (Italy), together with a consortium of European universities including University of Essex (UK), De Montfort University (UK), Universitatea de Vest din Timisoara (Romania), East Anglia University (UK), University of Belgrade (Serbia) and University of Rijeka (Croatia), organises the 16<sup>th</sup> edition of the Summer school **Consumer's Rights and Market Regulation in the European Union**, to be held 12-21 July 2023 in Udine (Italy), at the Campus of Legal and Economic Sciences.

The Summer school on Consumer’s Rights and Market Regulation is an intensive course (40 hours of lectures, a workshop and a moot court), held in English by internationally renowned academics. It addresses theoretical and practical issues related to the legal protection of consumers and the market regulation in the European Union. The scientific coordinator is prof. Elisabetta Bergamini, full professor of European Union Law at the University of Udine.

The available places for enrolment to the Udine Summer school are 40. Fifteen places are reserved for students from non-partner universities, who will be selected on a competitive basis. At the end of the course, students who have attended at least 90 percent of the scheduled hours and pass the final exam will receive an attendance certificate. Students from other Universities (depending on their home institution) may be able to translate their participation into ECTS points.

**ARTICLE 2. Admission requirements**

The course is targeted to undergraduate students, graduates no more than five years earlier, PhD from faculties of Law, Economics, Political Science or International Relations. Applicants must demonstrate proficiency in English in order to meet the entry requirements (minimum ability level for non-native speakers: B1 of the Common European Framework of Reference for Languages). A general knowledge of European Union Law is strongly recommended otherwise the School will provide appropriate teaching material in advance.

The entry requirements must be met within the set deadline for the submission of applications.

### **ARTICLE 3. How to apply. Selection criteria**

Students who are interested in applying to the Summer School on Consumer's Right and Market Regulation in the European Union must fill in the application form and submit it to [ip.europeanlaw.uniud@gmail.com](mailto:ip.europeanlaw.uniud@gmail.com). The following documents are requested: a curriculum vitae, a motivational letter (max 300 words), the transcript of exams and grades and a copy of the identity card or passport.

A ranking list will be drafted by a Commission composed by two Professors of the Udine Summer School on the bases of the academic qualifications held by the candidates, in order to ensure the maximum transparency.

The Commission will take into consideration for evaluation and selection purposes:

**A) The weighted average mark (at the moment of the submission) and the overall mark of European Union law (max 15 points)**

**B) Curriculum vitae (max 10 points)**

The Commission will take into account training experiences e.g. periods of study and internships carried out abroad (in particular, Erasmus projects and study trips), as well as candidates' organisational and relational skills, such as the ability to cooperate and to work as part of a team.

**C) Certified language skills (max 5 points)**

- Only certified language skills will be evaluated (priority will be given to those skills certified according to the Common European Framework of Reference for Language).

**In the event of an equal score, the younger candidate will be preferred.**

The ranking list will be communicated personally to candidates at the email address used to submit the application.

In case of renunciation of one or more applicants or extension of the available places for enrolment, those who ranked next highest to the selected candidates will be given the opportunity to join the programme. Failure to complete the application form will result in the automatic exclusion from the selection.

### **ARTICLE 4.**

#### **Payment**

Application deadline is **31<sup>st</sup> May 2023, 12:00 pm GMT**. Applications received before 30<sup>th</sup> April 2023, 12:00 pm GMT will benefit from the early-bird registration fee.

## OVERVIEW

Within the framework of the Jean Monnet Module “CoRiMaR” (2020-2023), the University of Udine (Italy) organizes the 16<sup>th</sup> Summer School on ‘Consumer’s Rights and Market Regulation in the European Union’, in cooperation with a consortium of European universities, now including University of Essex (UK), De Montfort University (UK), Universitatea de Vest din Timisoara (Romania), East Anglia University (UK), University of Rijeka (Croatia), University of Belgrade (Serbia) and University of Szeged (Hungary).

Since 2008, almost 400 students and 30 lecturers from all over Europe (including from previous partner universities) participated in our summer school.

Our goals are:

- To offer a quality and intensive training, focusing on transnational developments at the EU level;
- To promote the sharing of knowledge, experiences and practices between participants from different countries;
- To help participants in developing incisive reasoning skills and other soft skills such as team working, problem solving and argumentative reasoning.

The 2023 Summer School will consist 40 hours of lectures, a workshop and a moot court. It aims to provide a comprehensive training on the legal discipline of consumer protection and market regulation in the European Union Law, with a particular reference to digital technologies, the following relevant aspects:

- 1) Consumer protection and empowerment issues;
- 2) Private international law issues;
- 3) Dispute resolution and redress issues;
- 4) Market regulation.

The Summer school will be based on tested participatory methodology, including interactive discussions and case studies. The topics will be analysed adopting an interdisciplinary approach, involving trainers from different disciplines and background. The training material will be available on a devoted training platform.

The Summer school is designed for undergraduate students, graduates no more than five years earlier, PhD from faculties of Law, Economics, Political Science or International Relations and intending to upgrade their knowledge and competences on the specific topics of the course. A general knowledge of European Union Law is strongly recommended otherwise the School will provide appropriate teaching material in advance.

All the activities will be held in English. Therefore, participants are asked to be fluent in English in order to actively participate to the course.



## PERIOD

The summer school will be held from 12 July to 21 July 2023 in a blended format: initial 3 days online for everyone (12-13-14 July) and the following 5 days (17-21 July) either in virtual or in presence format on attendant's choice.

## ENROLMENT AND TUITION-FEE

The available places for enrolment are 40. Fifteen places are reserved for undergraduate students, graduates no more than five years earlier, PhD from faculties of Law, Economics, Political Science or International Relations.

### Are you coming by plane?

The Regional Airport (Ronchi dei Legionari) is 41 km far from the city.

Public Transport company APT operates bus services connecting the airport to UDINE (Coach no. 51 - also non-stop via motorway).

Updated schedules and fares are available on APT Gorizia website.

Tickets can be purchased at the airport:

- In the Arrivals Hall, with an automatic machine for self-ticketing;
- In the Departures Hall, at the Tourist Information desk (Turismo FVG).

If you land at Venice – Marco Polo Airport or Treviso Airport, then you can easily reach Udine by train, both from Venice – Mestre or Treviso Centrale train station.

A4/A23 motorway goes through Udine. If you come from North (Austria), take the "Udine nord" exit. If you come from all the other directions (Venice and Trieste/Slovenia), take the "Udine sud" exit.
